



Oligopoly: Community Checkers

Touchstone RSVP LAUGH Gatherings

A device-driven community discovery model for churches, nonprofits, community organizers, and other groups exploring whether showing up matters.

ONE PERSON. ONE CHECKER.

Each person is a single checker moving through life one precious moment at a time. There is no opponent to defeat. Community Checkers invites voluntary moments of Identity, Trade, or Gratitude - and every person may participate, observe, walk away, or scan nothing.

THE RESEARCH QUESTION

When money is removed from the initial decision, how often does curiosity become intention, intention become presence, and presence become personally confirmed fulfillment?

HOW THE PROPOSED EXPERIENCE WORKS

1

Discover

Receive or share the postcard. Read first; no registration is required.

2

Choose

Select one Practice FAITH word and place a \$0 backorder.

3

Reserve

The requested touchstone remains reserved pending personal pickup.

4

RSVP

Choose one scheduled proposed LAUGH gathering. RSVP reserves capacity.

5

Show up

Arrive voluntarily, check in affirmatively, and choose any available seat.

6

Fulfill

Pick up the reserved touchstone; optional Y/Y/Y may confirm delivery.

WHAT THE ORGANIZATION PROVIDES

- A welcoming, accessible gathering space and a named coordinator.
- A disclosed capacity and open-seating plan.
- A safe inventory, check-in, pickup, and exception process.
- Volunteers trained in privacy, choice, and no-judgment language.
- Written acceptance before public affiliation is displayed.

WHAT PARTICIPANTS MAY CHOOSE

- Participate as a MEGAvoter messenger.
- Observe as a free YAM'er observer.
- Walk away at any point.
- Scan nothing and remain individually unrecognized.
- Attend a later gathering without moral or character judgment.

GOD WINK OPEN MIC

Suggested celebration: Offer a welcoming, time-limited open mic where anyone may voluntarily share the Practice FAITH word they chose, the Peace Pentagon branch they selected, or why gathering together feels like a God Wink moment. Speaking is never required. Listening, passing, leaving, or sharing nothing are equally valid. Obtain separate permission before recording, photographing, quoting, or publishing anyone's story.

IMPORTANT SEPARATION

The \$0 backorder reserves inventory. The event RSVP reserves gathering capacity - not a particular seat. Arrival proves presence. Pickup is fulfillment. Y/Y/Y is optional mutual confirmation. None of these actions automatically creates church enrollment, research consent, prize entry, membership registration, a financial pledge, or guaranteed future participation.

Measure the moment. Protect the person.

The proposed Oligopoly adventure follows voluntary smartphone actions across three levels: Identity, Trade, and Gratitude. The device is a pseudonymous presence object - not a license to track the individual.

AFFIRMATIVE DEVICE ACTION A person is recorded only after choosing an authorized QR action. No scan means no individual encounter record.	NO PASSIVE SURVEILLANCE No background check-in, continuous location history, facial recognition, hidden fingerprinting, or automatic church/research enrollment.	THREE QR DOORWAYS Identity - voluntary presence. YAM-is-On - proposed trade intention. Seeking Gratitude - presence without money.

THE Y/Y/Y GUIDELINE

Y1	Was it delivered?	The reserved touchstone was personally handed over.
Y2	Did it reach the intended destination?	The intended recipient received the reserved item.
Y3	Do both people agree it happened?	Issuer and recipient independently confirm the same encounter.

True = Y1 AND Y2 AND Y3. Only Y/Y/Y records True. Any other result means proof was not established - never that a person is dishonest, unworthy, or lacking FAITH.

KEEP CONSENT SEPARATE ● Organization participation agreement ● Event RSVP and affirmative check-in ● Research participation consent ● Marketing contact permission ● Membership and commerce terms ● Prize entry, if ever offered	OBSERVE STAGES, NOT CHARACTER ● Discovery and \$0 backorder ● Invitation and confirmed RSVP ● Arrival and personal pickup ● Optional Y/Y/Y confirmation ● Reschedule, no-show, release, or later pickup ● Repeat participation, observation, walk-away, or no scan

READINESS GUIDELINES

1 Accept in writing Define role, venue, capacity, contacts, and public-name permission.	2 Protect choice Honor participate, observe, walk away, no-scan, speak, listen, and pass outcomes.
3 Control inventory Reserve each stone through pickup, release, or a disclosed expiration.	4 Separate and protect research Collect service data until qualified ethics/IRB review; separate contacts from devices and report aggregates.

NEXT STEP: Review the proposed guidelines; identify one coordinator, one possible RSVP-only gathering, and one safe fulfillment workflow. Public promotion begins only after written acceptance and final privacy, legal, accessibility, safety, and research-ethics review.
